Coimbatore, Feb 2: As many as 36,764 college students belonging to backward communities were benefited to the tune of Rs 21.73 crore during the 2019-2020 fiscal, Dr M Mathivanan, Director, Backward Classes and Minorities Welfare revealed. Speaking at the review meeting held at the collectorate meeting hall, he said that Coimbatore district topped the list in being given education assistance across the State.

Regarding loans under Tamil Nadu Backward Classes and Economic Development Corporation (TABCEDECO), he said that action is being taken to disburse Rs 193.47 lakh benefiting 422 farmers and public for digging of borewells and for self employment purpose and added necessary measures were being taken to sanction Rs 1.36 crore to beneficiaries under Tamil Nadu Minorities Economic



Development Corporation Limited (TAMCO) scheme.

On priceless bicycle scheme, he said that Coimbatore district was allotted with 17,232 cycles to be given to higher secondary school students and added that of which 12, 128 cycles have been already distributed while directing the concerned officials from the school education department to speed up in distributing the balance 5,104 cycles soon.

Under the rural girl

child education motivation scheme, he said that a financial assistance of Rs 500 is being given to children between 3rd and 6th class belonging to backward and most backward class girls. The district administration across the State has been directed to ensure the disbursement of the financial aid of Rs 500 per year.

Further, the director called upon the backward and most backward class people to avail the scheme of priceless

sewing machines and iron boxes through the district backward classes and minorities welfare department at the collectorate. And the eligibility for the scheme is Rs 72,000 income per annum.

Others who were present at the meet included District Collector K Rajamani, DRO Ramadurai Murugan, PA to collector (general) Muthuramalingam and CEO Usha besides officials from Nilgiris and Tirupur districts.

IMA begins relay hunger fast against Mixopathy

Coimbatore, Feb 2: Indian Medical Association, Coimbatore branch while thanking Tamil Nadu government for assuring the purity of the system of medicine and not for Mixopathy is holding a nationwide relay hunger fast from February 1st to February 14th at various designated places. And this demo is against the principles of Mixopathy and not against the government.

In a press statement, Dr.V.Rajesh Babu, president stated that the National education policy 2020 is towards medical pluralism and paves way for lateral entry of Paramedics & other systems of Indian Medicine Graduates into practice of Modern Medicine. Similarly with the aim of one country one system of medicine NITIAAYOG has formed 4 committees vide Medical Education, Practice, Public health and Medical research to formulate means for integration of all systems of medicine vide AYUSH



and Modern Medicine into one system which is a Myxopathy system. The recent notification from Central Council of Indian Medicine (CCIM) approved MS (General Surgery) PG degree by Ayurvedic graduates as Shalya Tantra & Shalakyia Tantra and will be allowed to do 58 types of surgeries which includes technically competent procedures like cholecystectomy, cataract, ENT, Plastic surgery, dental etc.

All these steps are towards one system of medical practice

'Mixopathy' which will be detrimental to public & the sanctity of the individual system of medicine gets diluted and will be lost. To save the innocent public and to preserve the sanctity and purity of systems of medicine, IMA demands withdrawal of CCIM notification and the 4 committees formed by NITI AAYOG.
