Review Report to the Board of Directors of Flora Textiles Limited.

1. We have reviewed the accompanying statement of unaudited financial results of Flora Textiles Limited for the quarter ended 30<sup>th</sup> June, 2022. This statement is the responsibility of the Company's Management and approved by the Board of Directors. Our responsibility is to issue a report on the Statement based on our review.
